The Governor (Chancellor) has constituted a Search Committee to recommend a panel of names to the Chancellor for appointment as Vice-Chancellor, Himachal Pradesh University, Shimla.

The Search Committee invites application for the position of Vice-Chancellor, Himachal Pradesh University, Shimla as per provision prescribed in Para 7.3.0 of the University Grants Commission Regulations-2010 read with Section 12(1) of the Himachal Pradesh University Act, 1970. The Vice-Chancellor being the academic as well as administrative head is expected to be a visionary with proven leadership qualities, administrative capabilities as well as research credentials. The following specific criteria have been included by the Search Committee for assessing the suitability of the prospective candidates for the post of Vice-Chancellor:

1. Experience in the field of Higher Education as Professor or equivalent at least for 10 years.(The decision of Search Committee regarding what is equivalent would be final.)
2. Administrative experience in the field of higher education not below the rank of Professor and Head of Department in a University at least for 5 years.
3. Experience of working in Statutory Authorities/Statutory Research Institutions such as Board of Studies, Academic Council, Executive Council, Board of Management, Senate etc.
4. Should be recognized with fellowship of professional societies, academies, awards and honours reflecting his eminence in research, education and extension.
5. The applicant should also be able to give an undertaking that she/he will be able to take up the assignment immediately.
6. In case of persons already working/employed in government Departments/Autonomous Bodies, the application should be sent through proper channel alongwith vigilance clearance. However, they may send an advance copy of the application at the address mentioned below.
7. Applications found incomplete or received late will be rejected.
